ORDER

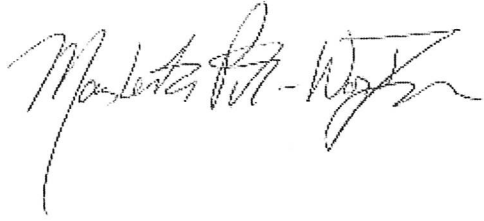
AND NOW, this 25th day of January, 2024 after hearing on the Monroe County Election Board's (hereinafter "Petitioner") Proposed Order Appointing District Election Board Officers, and upon being advised by Petitioner's Counsel, County Solicitor Todd Weitzmann, that Petitioner proposes a new slate of District Election Board Officers in the Middle Smithfield Election Districts 1, 2, 3, and 4, **IT IS ORDERED** that:

1. This matter is **CONTINUED** to allow Petitioner to publish notice of same.
2. To that end, Petitioner shall continuously post public notice of its proposed District Election Officers and this Order containing the date and time of hearing at which this Court will make such appointment, on the polling place of such district, and in the immediate vicinity thereof, commencing at least five days prior thereto.
3. Petitioner shall continuously post public notice of its proposed District Election Officers and this Order containing the date and time of hearing at which this Court will make such appointment on the official Monroe County website commencing at least five days prior thereto.

4. Any objections to the proposed District Election Board Officers by registered electors of the districts to be affected shall be filed with the Monroe County Prothonotary's Office on or before the close of business on February 8, 2024.

A HEARING for the appointment of District Election Officers is scheduled for the 9th day of February, 2024, at 1:30 p.m., in a Courtroom to be determined, Monroe County Courthouse, Stroudsburg, Pennsylvania.
