WHEREAS, the Board of Supervisors of Middle Smithfield Township, Monroe County, has determined it necessary to collect certain fees for rendered services and does hereby amend the established Middle Smithfield Township Fee Schedule ("Fee Schedule") as attached hereto; and


WHEREAS, it is necessary that an appropriate Fee Schedule be established sufficient to defray all expenses that may be incurred by the Township in connection with consideration of various applications, permits, hearings, and/or other general requests; and

WHEREAS, the Township of Middle Smithfield Board of Supervisors annually reviews and amends the Fee Schedule, as necessary. This resolution does hereby repeal and supersede prior resolutions which are inconsistent with the provisions of this resolution; and

NOW THEREFORE, be it resolved, by the Board of Supervisors of Middle Smithfield Township, that the attached Fee Schedule be established and implemented for calendar year 2022 and effective January 1, 2022.

RESOLVED AND ENACTED by the Board of Supervisors of the Township of Middle Smithfield this 13th day of January 2022.

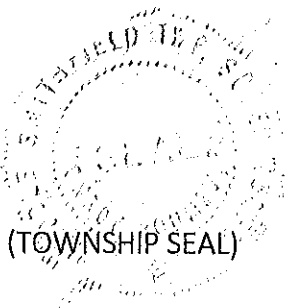
