We have many things to be thankful for this year, as the season of gratitude starts with our Veterans. The township was honored to host a complimentary luncheon for veterans on November 2nd at the Community & Cultural Center, organized by resident Andy Zaso (see more on page 11). And, of course, we are thankful to add to the **Hometown Heroes** banner program – you can see more of our resident veterans honored by more banners at the Community & Cultural Center when attending the Tree Lighting this year.

Of course, we are excited for the upcoming **Tree Lighting**, always the Saturday after Thanksgiving at Echo Lake Park, which also kicks off the Shop Local season (your **2024 Shop Local** Discount Cards are included in this issue! Please activate them today.) Last year, there was something new – a stage by Law Sound and Lighting that enabled the performers – and Santa – to be seen and heard much better! This year, there are more improvements – see page 10 to find out about two new exciting things.

The Person of the Year and Volunteer Appreciation Banquet will be January 24, 2024 (always the Friday after Martin Luther King Day), see page 12 for holiday happenings from our 2023 People of the Year, and stay tuned for more information about the 2024 finalists and judges. We are grateful that we will come together again with the community to celebrate our many volunteers and civic minded community members.

Please join us for our next presentation to the public – the **presentation of the 2025 budget** on Thursday, November 21st and the **adoption of the budget** on December 19th. The staff and Supervisors have been hard at work planning 2025 projects in tandem with preparing the budget for 2025; the most significant change of the decade is that the Country Club of the Poconos Golf Course was transitioned to private ownership in third quarter of 2024, along with the sale of undeveloped land, putting over 409 acres back on the tax rolls. And we welcome The Poconos Club, as new development provides jobs, as well as an increase in the LST tax (which goes to our fire and ems), and increased earned income tax. This privatization eliminates the burden on the taxpayer and decreases township expenses of owning a golf course and banquet hall.

2024 RECAP & A LOOK AHEAD TO 2025

As you read this, the township Supervisors and staff are working on the 2025 Budget. Budget preparations include input from each department and require a detailed vision of what is expected for the coming year.

We also have to acknowledge some of the major changes in our operations from 2024. One of the most significant changes includes the sale of the golf course. Not only are we no longer funding an annual loss, but we have decreased payroll expenses, insurances, and many other aspects that cost the taxpayers for many years. Even though we said goodbye to a number of employees, we are thankful the new owners retained all of the staff this season.

Another significant change includes the elimination of the Cable Franchise Fee. This fee, enacted many years ago, was a source of income for the township to fund the 911 Center and our volunteer fire and EMS services. Alternatively, the township enacted a fire and an EMS tax where all funds collected are disbursed to our volunteer organizations. (Funding of the 911 Center is from operational income, not the fire or EMS tax.)

Just like each of our homeowners and business owners, costs for everything have gone up. Labor costs increase each year, materials and equipment have seen a substantial increase year over year, and all of our utility costs have gone up. We have, however, taken many steps to decrease costs where possible.

In 2025, look for even more improvements throughout the township and, in hopes of receiving a few sizable grants, a new park in Wooddale may be developed and accessibility improvements along Route 209 and at our Community & Cultural Center.

WE SINCERELY THANK ALL OF OUR COMMITTEES:

The **Economic Development Committee** advises the Board of Supervisors on matters dealing with the advancement and expansion of the local economy. A resource to the business community dedicated to the success of our businesses, the EDC strives to create a diverse business community that is prosperous and innovative while built on a stable economic foundation.

The **Historical Commission** is comprised of local residents and committed volunteers that aim to foster and promote public knowledge and interest in Township history. Since its establishment in 2012, members host interactive, fun events such as Marshalls Creek Mastodon events, Memory Makers luncheons and work to procure historical markers for significant sites.

The **Parks and Recreation Committee's** mission is to retain enough open space for our residents' use, maintain the beauty and character of the area, and maintain full functioning park equipment and facilities that will provide a number of recreational activities and events throughout the year. Since the beginning of 2013, the Parks and Recreation Committee have added playgrounds, a community garden, and re-invented the Bark Park. They conduct family friendly events such as the Egg Hunt, Trunk or Treat and Tree Lighting.

The **Planning Commission** serves as an advisory board that makes recommendations to the Supervisors, Zoning Hearing Board, and to the Zoning Officer. The Commission also reviews all major and minor subdivisions, land development plans and any new zoning changes such as variances or home occupations. The members of the Commission also work on new zoning changes and ordinances.

The **Zoning Hearing Board** is a quasi-judicial body that renders decisions on specific types of land use appeals and applications.

The primary purpose of the zoning hearing board is to help assure fair and equitable application and administration of the zoning ordinance. The zoning hearing board hears appeals from the zoning officer's determinations and grants relief from literal enforcement of the zoning ordinance in certain hardship situations by means of a variance.

The **Revitalize 209 Advisory Committee** was established in 2023 to advise the Board of Supervisors on matters pertaining to the applications for the Revitalize 209 Grant Program. The Revitalize 209 Grant is a matching grant program set to help fund improvement projects that are visible from 209.

SEWER DEPARTMENT CAPITAL IMPROVEMENTS

We got the Grant! We applied for a DCED Local Share Account Fund (Gaming Funds) Statewide grant in 2023 to extend the township's sewer line from Gravel Ridge Road to Route 402, and we were awarded \$111,137 for this project. This will extend the sewer line to the C2 commercial zone (light commercial) along Route 402.

The Township will also apply for the 2024 round of DCED statewide Local Share Account grant to further extend the sewer down Route 402. This will be helpful to business development along Route 402.

Reminder: 4th Quarter sewer payments were due on November 1st. \$25 late fee will be applied beginning December 2nd.

KNOW WHERE THE SNOW GOES!



We are always concerned about our roads and make every effort to have them cleared in winter as quickly as possible. As portions of our Liquid Fuels funds are used to pay for salt and cinders for winter maintenance.

Our township is one of the few that uses a treated salt product called Clearlane, which works faster and lasts longer. Compliments are often received about the conditions of our roads, compared to State and other township roads.

When plowing is being done, there is no place to put the snow other than the road shoulder. Residents often ask us to avoid their lawn or driveway, which is impossible. The maintenance of our roads is necessary to allow for emergency vehicles and motorists to drive safely. One consideration is that when plowing or shoveling your driveway, put as much of the snow to the left of your driveway (looking at your house) so that when plows come down the road, large piles of snow are not pushed back.

OH SNOW- BRUSH UP ON CHAPTER 138!

Snow is quickly approaching. It is important, especially at this time of year, to be aware of Chapter 138 of the Township Code of Ordinances which regulates parking as well as snow removal and the penalties that can be applied for non-compliance.

If a snow emergency is declared by the Township, or if more than 4 inches of snow has fallen, it shall be unlawful to park a vehicle on any public road and right of way in the Township. Doing so could result in a fine. If a vehicle is found unattended and in violation of a provision of Chapter 138, the Township may have that vehicle removed.

In addition, it shall be unlawful to throw, shovel or otherwise move, pile or dump snow or ice removed from sidewalks, driveways or other areas onto any public road. This also could result in a fine. These provisions are for the safety of our residents and our Public Works Department employees who work tirelessly during winter storms to ensure our roads are clear.

After decades of anticipation, the restoration of passenger rail service from NEPA to New York City is finally becoming a reality as construction is officially starting! Read on for more good news:

Route 611: is open! Since December of 2022, Route 611 in the Delaware Water Gap area has remained closed after heavy rains led to a rockslide along Mount Minsi. In January, I began holding multi-level meetings between agencies and elected officials to cut the bureaucratic tape and get this major lifeline of our communities re-opened. The opening of 611 will bring much-needed relief to local businesses, residents and communities affected by the extended road closure.

Passenger Rail

I recently announced \$8,958,919 million in federal funding to begin construction to bring back Amtrak passenger rail service between Scranton, PA and New York, NY. The award will kick off long needed railway rehabilitation and track improvements to begin the process to restore service between the communities via the Lackawanna Cut-Off. The funding comes from the Consolidated Rail Infrastructure and Safety Improvements (CRISI) grant program, made possible by the Infrastructure Investment and Jobs Act (IIJA).

Restoring passenger rail has been a major goal of mine since my first day on the job. That's why I'm thrilled to help announce that we're getting closer than ever to seeing the realization of our passenger rail project. We now have a once-in-a-lifetime opportunity to do something transformational for our region.

I'm excited to share the success of my bipartisan efforts! In recent months, several of my legislative proposals have been signed into law, each aimed at making a positive impact on our community and the state as a whole.

First, I would like to highlight my legislative package, Senate Bills 1132, 1133, and 1134. These bills were successfully enacted into law, allowing more flexibility of the existing tax revenue for our EMS and Fire Companies. This new law empowers local governments to remove the restriction that prohibits fifty percent of this revenue to be used for personnel. Allow local governments to lift this restriction helps our EMS and fire companies to recruit and retain any paid employees. This is about ensuring we have emergency responders and response times are as quick as possible when you dial 9-1-1.

This legislation was a suggestion of our community member, Debbie Kulick, of Bushkill EMS. This is exactly how government should work – people voice their concerns, make suggestions, and as your lawmaker, I research and consider drafting legislation. The best laws come directly from people and their voices.

Additionally, for over two years I spearheaded, drafted, and developed Senate Bill 840 which has now also been enacted into law. This establishes a permanent Alzheimer's Disease and Related Disorders (ADRD) Division and an ADRD Advisory Committee within the Department of Aging. These new entities will collaborate with experts and stakeholders to advocate for effective policies, secure crucial federal funding, and ensure that Pennsylvania is better equipped to address the growing Alzheimer's crisis.

As we roll into the winter, there is a lot to look forward to! Next month, I am hosting a Veterans Expo at Northampton Community College Pocono Campus

Join state agencies, local agencies, non-profits, and enjoy light refreshments. This free event is scheduled for Friday, December, 6th from 10 a.m. to 1 p.m. Meet us in Pocono Hall in Room 108. Stay tuned for future satellite hours! We intend to announce dates very shortly. Check with our social media or Middle Smithfield's website. Meet with my staff between 10 a.m. and 3 p.m. and get the assistance you need with state services, including but not limited to Property Tax-Rent Rebates, disability placards, senior reduced vehicle registration, and unemployment. Note that the deadline for the Property Tax-Rent Rebate is coming up fast! Do not wait until December 31st to apply.

Late last month, the Commonwealth Finance Authority approved several grants for our region. I am most pleased to report that Middle Smithfield Township received \$111,137 for an extension of public sewer services along Route 402 to connect the existing pump station at Resica Elementary School with the commercial district along Route 402. Projects like these have a real impact and will assist in keeping local taxes low. (See page 12)

Monroe Career & Technical Institute is also set to receive \$1,000,000 for their needed expansion. Career & Technical Education is important to our region's success. I am grateful that Governor Shapiro and his administration recognize the need to invest in our future.

REPRESENTATIVE TARAH PROBST

189th Legislative District



I hope everyone had a great summer and is looking forward to the holiday season.

Our area received some great news recently, as East Stroudsburg Area

School District was awarded two Public School Facility Improvement Grants totaling \$818,941. The first \$417,545 grant will be used for the replacement of boilers and controls at JT Lambert Intermediate and Smithfield Elementary Schools. A second \$401,396 grant will go toward data cabling replacement projects at JT Lambert Intermediate. Given the exorbitant school property taxes in Monroe and Pike counties, I am especially pleased to see those funds provided to ESASD.

The grants build on the strong 2024-2025 state budget that we passed this summer to help relieve the burden on local taxpayers even more. The budget includes \$9.6 million for ESASD, and for the first time, it includes funding that could be used by the school district to lower property taxes, possibly through the state homestead/farmstead exemption. Did you know that every homeowner is eligible for a property tax cut from the proceeds at Pennsylvania's casinos? Homeowners should contact the Monroe County assessment office for a copy of their county's homestead and farmstead application form.

Working with my House Democratic Caucus leadership team, I was able to secure a \$30,000 grant for local nonprofit Angels and Dragonflies to be used for operational support and supply/equipment purchases. (See page 12)

Find information about Board of Supervisor meetings, committee meetings, permits, events, parks, roads, view the calendar and more.

How it works:

Text HI or a keyword such as PERMITS, PARKS, or CLEANUP to 570-223-5400. The TextMyGov system will respond with answers based on the keywords you text in. Stick to one or two keywords at a time. Full sentences are not necessary and may confuse the system.

Opt-in to receive text alerts from the Township:

You can also opt-in to receive text alerts from the Township. By opting in, you will receive text messages about upcoming events, emergencies, and other important Township information.




MARSHALLS CREEK FIRE CO. DUAL PURPOSE TRUCK ON ORDER



Marshall's Creek Fire Company

The Marshall's Creek Fire company is using the Middle Smithfield Township Tax monies to help fund our new fire apparatus on order.

Expected in 2028 the Pierce Enforcer Chassis PUC will be replacing a 26 year old rescue truck and a 37 year old Engine. This truck will serve dual purpose and be designed for both rescue and fire suppression capabilities. This purchase would not be possible without the funding provided by the Residents of Middle Smithfield Township that we proudly serve.



CARBON MONOXIDE SAFETY

Often called the invisible killer, carbon monoxide is an invisible, odorless, colorless gas created when fuels (such as gasoline, wood, coal, natural gas, propane, oil, and methane) burn incompletely. In the home, heating and cooking equipment that burn fuel can be sources of carbon monoxide.

CO alarms should be installed in a central location outside each sleeping area and on every level of the home and in other locations where required by applicable laws, codes or standards. For the best protection, interconnect all CO alarms throughout the home. When one sounds, they all sound.

HOME HEATING EQUIPMENT

Have fuel-burning heating equipment and chimneys inspected by a professional every year before cold weather sets in. When using a fireplace, open the flue for adequate ventilation. Never use your oven to heat your home.



BUSHKILL FIRE CO. NEW RESUE PUMPER



Bushkill Fire Company will be using the Middle Smithfield Township designated fire tax money toward the annual payment of a new Spartan Gladiator Rescue Pumper.

The apparatus will seat six firefighters have an on-board water tank on 1,000-gallons and a 2,000 gallons-per-minute pumping capacity. This apparatus will be replacing a dry walk-around rescue truck with no fire suppression capabilities.

The new apparatus will serve as a multi-purpose vehicle providing the same rescue capabilities as the previous rescue truck, but increasing fire suppression capabilities to the primary response area of Bushkill Fire Company and surrounding areas.



YOUR FIRST LINK TO EMS HEALTHCARE

When they say, "What difference a day makes", what it really means to our local EMS (Emergency Medical Service) providers is, "What a difference the EMS tax support makes!" This year Middle Smithfield Township joined by Smithfield Township implemented both an EMS and Fire tax to help support the organizations serving our communities. The tax helps support in part, Bushkill Emergency Corps, Lehman-Pike EMS, Suburban EMS and Marshall's Creek Fire Company BLS services.

The difference the additional funding has made will soon be evident as Bushkill Emergency Corps was able to order and commit to sustaining funding for the purchase of two new ambulances to its fleet. One ambulance will replace the costly to

maintain, 24-hour-a-day Advanced Life Support unit (2009) with a new 2024 two-wheel drive box ambulance unit costing about \$230,000 when complete. The second unit replaces a no longer acceptable 1992 Basic Life Support unit with a 2023 van-type unit costing about \$125,000. These units will upgrade the existing fleet and will assure dependable transport of patients to our local hospitals.

Bushkill Emergency Corps has chosen to acknowledge this support by extending to all residents of Middle Smithfield and Smithfield Townships (primary coverage areas) the equivalent of a subscription to the organization. What this means is if a patient is responsible for a remaining portion of a bill for transport, the organization will deduct up to \$500 from the remaining balance.

As technology changes in the availability of equipment, and training requirements increase, over time this funding will continue to allow Bushkill Emergency Corps to upgrade equipment that will better serve our patients. At the recent 5th

NEWS FROM THE SHAWNEE VOLUNTEER FIRE COMPANY – STATION #36

Shawnee Fire Company

On October 22, 2025 The Shawnee Volunteer Fire Company placed an order for a Pierce Enforcer Pumper. This new engine will take approximately 4 years to build, to be received, and to be placed into service. This piece of apparatus will allow the Fire Company to continue to service Smithfield and Middle Smith-

field Townships for many years to come. The unit will seat a driver, officer, and 5 crew members. 6 seats will have MSA airpacks with 4 extra packs and spare air bottles. The unit will also have : 2,000 gpm pump, 1,000 gallon water tank, a 40 gallon foam cell, large diameter hose, and multiple handlines. This unit will be replacing our 1997 Pierce Quantum pumper that is currently in service.



With the funding from Middle Smithfield Township, the fire company has been able to: crack seal the entire parking lot, convert all of the station lighting to LED thereby saving operating costs/energy, replace one of the roofs on a storage shed, and will be used to pay down the only debt by paying off our 3,500 gallon tanker which will allow the company to place more money down on the new engine and lessen the amount of debt incurred replacing this engine. The cost for the new engine is 1.4 million.

In 2025, the Shawnee Volunteer Fire Company will be celebrating its 80th Anniversary on February 14th. The Fire Company would like to thank the Middle Smithfield Township Board of Supervisors and its constituents for their continued support in the past and look forward to continuing to work together to meet the ever-changing needs of the communities that we serve.

As the Holidays are quickly approaching, the Shawnee Fire Company would like to wish everyone a safe, happy, and healthy Holiday season!

Annual Bushkill Emergency Corps fundraising Gala, the organization shared information that detailed the cost of some of the current equipment used by EMS. Some of the items noted were: LUCAS CPR chest compressor system/\$20,015 each, Stryker Stair-Pro Stair Chair/ \$17,329 each, Stryker Power Pro XT package Ambulance Stretcher/\$74,586 each.

Bushkill Emergency Corps is also investing in its own providers by providing scholarships to advance their training to the Paramedic level. The organization looks forward to its recent second candidate, Wilfredo Crespo, completing his training in December and joining the previous recipient, Joseph Bolger, as part of the Advanced Life Support Staff.

Bushkill Emergency Corps thanks the Board of Supervisors for their vision for the future of services needed and their commitment to the organization and continued support as Bushkill Emergency Corps enters its 60th year of service to the residents and visitors of Middle Smithfield Township.
