RESOLUTION NO. 04-2016-2

A RESOLUTION APPROVING AND AUTHORIZING MIDDLE SMITHFIELD TONWSHIP'S SALE OF A  
USED 1996 FORD TRUCK TO THE BOROUGH OF DELAWARE WATER GAP

WHEREAS, the Township of Middle Smithfield ("Township") currently owns a used 1996 Ford F-250 truck, VIN# 1FTHF26H9TLB25334(the "Vehicle");

WHEREAS, Township Board of Supervisors (the "Board") has determined that the Vehicle is no longer used in Township operations and no longer needed by the Township;

WHEREAS, the Board finds that the resale value of the vehicle is \$500 or less;

WHEREAS, the Board finds that the Township would incurred an unnecessary expense in attempting to sell the Vehicle in the open market, or scrapping the Vehicle;

WHEREAS, the Borough of Delaware Water Gap (the "Borough"), a Pennsylvania municipal corporation, located in Monroe County, is in need of a vehicle on a short term basis, and agreeable to paying the Township's costs of transferring the Vehicle to the Borough; and

WHEREAS, the Pennsylvania Second Class Township Code, Section 1504(c), permits the Board to sell Township personal property to a municipal corporation without competitive bidding or advertisement.


NOW, THEREFORE, BE IT RESOLVED, by the Middle Smithfield Township Board of Supervisors as follows:


1. The Board approves and authorizes the sale of the Vehicle to the Borough for \$1.00.
2. Township Supervisor Michael J. Dwyer, Director of the Township's Public Works Department, is authorized to execute and deliver a Bill of Sale transferring the Vehicle, and to execute any further documentation required by the Commonwealth, or any other entity, to effectuate the transfer.


3. This Resolution shall be effective immediately.

Resolved this 14th day of April, 2016, by the Board of Supervisors of the Middle Smithfield Township at a lawful session duly assembled.


